This item was originally submitted as a no recommendation pending the completion of the departmental reviews and the posting process. However, staff has changed its recommendation to disapproval based on a Police Department recommendation for disapproval (attached). The Police Department disapproval is based on criminal history at the location and concerns with the applicant's capability, qualifications and reliability. Staff also notes that applicant must resolve any pending City of Phoenix building and zoning requirements, and be in compliance with the City of Phoenix Code and Ordinances.

The Police Department recommends disapproval of this liquor license application for the following reasons:

Location Criminal History:

During a review of the application it was found that there were multiple search warrants for the sale of narcotic drugs and drug paraphernalia served at this location. The location of the pending liquor application is one of the two store fronts and a small apartment complex owned by the applicant, Mr. Yoon. He is responsible for its maintenance and upkeep.

There were two search warrants served in 2015 and two additional search warrants in 2017. All of these search warrants were drug related served on apartments in the complex. During the investigation in 2017 several undercover "buys" were conducted. During those operations the manager of the complex was contacted and was facilitating the drug sales. Mr. Yoon was made aware of this and did not rectify it. He made a statement to the effect that his manager doesn't steal from him, therefore he would not be making a change in management.

During the service of the second search warrant several health and safety building violations were observed. The City of Phoenix Planning and Development inspectors responded and found multiple severe violations, needing immediate repair. Mr. Yoon was directed to repair the property to bring the residences up to code. If these life safety issues weren't immediately addressed the property would have been deemed uninhabitable. As the owner of the property Mr. Yoon is responsible for maintaining his property and keeping it safe for his residents which based on the inspection he failed to do.

Based on Mr. Yoon inability to maintain laws currently at his location we submit that he is not capable, qualified or reliable to hold a liquor license.
