STAFF PRESENTATION

Kevin Weight with the City of Phoenix Historic Preservation Office provided a presentation regarding the history of the building at the subject site, highlighting the age, integrity, and significance criteria required for the Historic Preservation Overlay and stating that the staff recommendation is approval.

QUESTIONS FROM COMMITTEE

Committee Member Olivas asked about the City's standards for HP properties in relation to the City-owned Duppa-Montgomery Adobe House. **Mr. Weight** replied that the City has hired a firm to begin preservation efforts of that building and it is currently in design phase.

Committee Member Starks asked for clarification on the color shown on one of the building facades. **Mr. Weight** replied that the color may have been added recently, but the current owner purchased the property with the last year.
