I would like to share my thoughts about this development. I want to make sure that it does NOT move forward.

It is planned to be too close to the wash to its west. The developer says they've done flood studies, but there's video of the area being underwater just a few years ago. This being the case, my feeling is that if city council and the other entities that would be involved if approved to move forward, all the same would also be liable for any damages, injuries or worse if the area was ever flooded.

As with the last development that was rejected north of the Anthem area, the following issues have not been addressed:

No more police or fire would be available leaving all residents in the area at risk.

No plans to address overcrowding in the nearby (public) schools. The claim by the land owner's counsel is that a new charter school will be the answer. Of course, parents may choose not to use this choice, so the public schools then become more overcrowded.

The only traffic concern that has been discussed is the intersection of Anthem Way and N 43rd Ave. The northbound exit ramp from I17 is already overburdened in the evening rush hour and has two left turn lanes. Residents turning left in the evenings already wait through 2-4 light cycles, there will need to be six left turn lanes at that exit. An answer for this could be for residents to go to New River Rd and come back south, but few will be willing to do so.

In an emergency there is not enough exits from the area in case of an evacuation. The developer claims there are several exits, but all but one winds through a residential neighborhood NOT designed for any type of through traffic. The only other exit is to use the one-way frontage road the wrong way. This would require police to change the traffic pattern and direct traffic, if they can get there since the area is so far away from the PPD area.

This area is also close to residents that use wells, and although it would be supplied with city of PHX water, there would without a doubt be a negative effect on the wells in the area.

The water treatment equipment is also in an area right between this development and the homes just to its south. There is no chance that there will not be unpleasant odor from this treatment area especially during our hot summer temperatures.

Please forward my feelings to those that can and should reject this proposal that is just ridiculous for the area.

Hi Kaelee I writing to in reference to the new development at 43rd ave and Circle Mtn.
It looks like I will not make it to the meeting on Tuesday , so I will share my deep concerns .
I am not opposed to any growth in the Phoenix area , but I have concerns of traffic and safety issues of my neighborhood on the west side of 1-17

1. More traffic starting in August when the new school opens at 43 rd ave and Circle mountain . It will add almost 1000 cars a day with those cars dropping off and picking up at the new school everyday on 43rd ave .
It will add more traffic back ups at 43rd and Anthem making left hand turns.. just like water it will find the easiest path . That means people will be using 45 ave or Old West trail , drive past the canyon school to go to Anthem way then turn left on Anthem Way to by pass the left turn at 43rd
This will put more traffic on quiet residential streets. More cars , more chance of kids and seniors being hurt.
2. More people on the west side of 1-17 (with one way in, one way out, a large culdasic) means more people more chance of emergency situations, more traffic means more time needed for emergency services to get help .
- 3 With the new housing development this will only make things worse for emergency services response times ,
4. Fixing 43 rd ave and Anthem way from what I hear will not happen for at least year maybe two due to budgets for the City of Phoenix. I don't know if you know this or not. The east side of 43 rd ave cannot be widen due to parts of the road are under Maricopa country control around Old West trail.
(I hope the City of Phoenix might take a harder look at when they approve projects they also make sure the infrastructure is in place before this are approved to not disrupt the neighborhoods)
- 5 . How can a developer build homes in a river bed and not have any repercussions from shifting the water flow to displace other parts of the bank up or down river? Is it worth the risk?
- 6 . To help soften the hard scape of the homes in our neighborhood. Can all homes on the perimeter be one story?
- 7 . With the school being built at 43rd ave and Circle Mtn. They have not been good neighbors starting out pouring 300 yards of concrete at 3 am waking people and myself up , working on Saturdays. I understand they have to open in August. They did get a special permit to bypass the zoning codes to have more work hours
My question to you is can there not be a permit issued to the developer to by pass zoning codes working before 6 am in summer and 7 am in winter.
Our neighborhood would have to listen to construction tractors early in the morning moving dirt and concrete tracks working on the middle of the night. For me that is a non starter and I will complain to after hours code enforcement like I have done about the new school.
8. Why can't the developer be in Anthem association? They help control the plants to keep mice out of the neighborhoods, will they use our parks in Anthem and not pay for them ? Can you stipulate they be in the Anthem Asse and obey the CCRs ?

Dear Ms. Wilson and Commissions on the Rio Vista Village Planning Committee:

We are Anthem and North Valley property owners who are writing to you today to ask that you please consider recommending **AGAINST** the request of El Dorado Holdings under Rezone Application Z-90-18-1 which would seek to rezone approximately 46.81 acres of land from S-1 to R1-6.

While we speak for ourselves, we also speak to numerous residents within the general Anthem area who are deeply concerned that this potential development will introduce a significant number of concerns as to traffic, flooding, pedestrian safety, additional pressure on already-strained Phoenix emergency services, additional pressure on Daisy Mountain Fire crews, and the general condition and maintenance of 43rd Avenue.

We respect the rights of the property owner to develop their land. We recognize that the land was purchased over 25 years ago with the eventual intention of development. However, the purchaser of the land bought the land FULLY KNOWING it was zoned as S-1. If the property owner wishes to develop that land fully under an S-1 designation, we respect that choice to do so. However, playing "bait and switch" to now request a rezoning to a substantially higher density was not a condition of purchase and the property owner should, in our opinion, respect the original zoning specification and if they choose to build residential homes, do so under that designation.

We also recognize that the general Phoenix plan speaks to North Valley development under densities in excess of S-1. However, while the Plan speaks to it, it is not a "blind" approval that every piece of available land would be a candidate for a density higher than what it was originally zoned. We, and many other local residents, strongly object to El Dorado Holdings using the General Phoenix Plan as a basis of the zoning change. We believe that the developer should honor the original conditions as to when they purchased the land and not try to find some illusory rationale to now justify a zoning change that will essentially continue to wreak havoc on the existing infrastructure that surrounds 43rd Avenue.

It is our further understanding that many individuals from New River, Desert Hills and Anthem have spoken in opposition to this proposed zoning change. Additionally, it is our understanding that the Anthem Community Council and Anthem Parkside Community Association, which collectively represent over 10,200 residential property owners in this local area, strongly oppose the zoning change. Their reasons are also our reasons:

(a) the significant increase of vehicular traffic on 43rd Avenue, which is a two lane road

- (b) the inability of the existing traffic light at 43rd Avenue and Anthem Way to handle current traffic, let alone another 200 - 300 cars daily, despite the willingness of El Dorado Holdings to financially support changes at the traffic light
- (c) the fact that the proposed subdivision has only one single point of ingress and egress and the extremely negative ramifications of that on emergency services
- (d) that El Dorado Holdings is planning to do some level of fill to the New River wash and most probably alter, to some degree, the flow of water towards homes which border this proposed subdivision to the South and to the West.

While there are many other concerns that most probably have been raised by others, we will focus on the above as sufficient to justify our request that the Rio Vista Village Planning Committee, the City of Phoenix Planning Commission and the City of Phoenix City Council to please DENY the request for rezoning to R1-6

Thank you for allowing us the opportunity to share our concerns.
