Hearing Summary

Mr. Christopher DePerro, the Abandonment Hearing Officer calls the meeting to order on October 27, 2022.

Ms. Alyssa Neitzel, the Abandonment Coordinator introduced abandonment ABND 220057 and read the case into the record by stating the applicant, location, and purpose of the request, as well as City staff research.

Mr. DePerro then started the discussion by asking the applicant if they would like to add any additional comments regarding the abandonment request.

Ms. Keilah Casillas, applicant gives floor to Ms. Pamela Hicks, SRP representative.

Ms. Pamela Hicks discusses area to be abandoned.

Ms. Maja Brkovic, Streets Transportation Representative requests to see exhibit the developer has provided for this hearing to get a better understanding of the request.

Mr. Remigio Cordero, Residential Subdivisions Team Leader adds comment regarding plan submittals.

Mr. DePerro, details the Replat and rededication that must be done for this abandonment. Also, nothing can be included as a requirement of stipulation of abandonment before it goes to city council.

Ms. Neitzel reads stipulation recommendations from various city departments as well as stipulations of approval.

Mr. DePerro, modifies stipulation 1 to state "the area to be abandoned shall be in conformance with the exhibit dated October 25, 2022." Stipulation number 5 now moved to 2 with no changes.

The Hearing Officer grants conditional approval for abandonment 220057 subject to stipulations in staff report with modifications.

Stipulations of Conditional Approval

The request of abandonment is conditionally approved by the Abandonment Hearing Officer. The following stipulations will need to be met:

- 1. The area to be abandoned shall be in conformance with the exhibit dated October 25, 2022.
- 2. All stipulations must be completed within **two years** from the Abandonment Hearing Officer's decision.
