<i>CONNECT PEOPLE AND PLACES CORE VALUE; OPPORTUNITY SITES; LAND USE PRINCIPLE: Support reasonable levels of increased intensity, respectful of local conditions and surrounding neighborhoods.</i> The site is located along Missouri Avenue and is within the Missouri Avenue Land Use Study area. The proposal is consistent with the Land Use, Neighborhood, and Conservation, Rehabilitation and Redevelopment elements for recommendations of support for rezoning cases. These elements were developed by a Subcommittee of residents and Village Planning Committee members to ensure that projects are compatible with nearby residential uses and to ensure responsible reinvestment and development along the corridor. The proposal is respectful to local conditions and the adjacent neighborhood.			
<i>BUILD THE SUSTAINABLE CITY; TREE AND SHADE; DESIGN PRINCIPLE: Integrate trees and shade into the design of new development and redevelopment projects throughout Phoenix.</i> As stipulated, the proposal will provide a detached sidewalk along Missouri Avenue with shade trees planted near the sidewalk.			

STRENGTHEN OUR LOCAL ECONOMY; LOCAL AND SMALL BUSINESS; LAND USE PRINCIPLE: Facilitate adaptive reuse of older, underutilized properties to create mechanisms for new local and small businesses to operate, thrive and grow.

The redevelopment of the site will offer new jobs in the area through the adaptive reuse of an older structure. The proposed retail spaces are small and will allow the opportunity for local business owners to operate their business at a brick and mortar location. The smaller retail spaces will allow a greater amount of local entrepreneurs at a centralized location in the city.

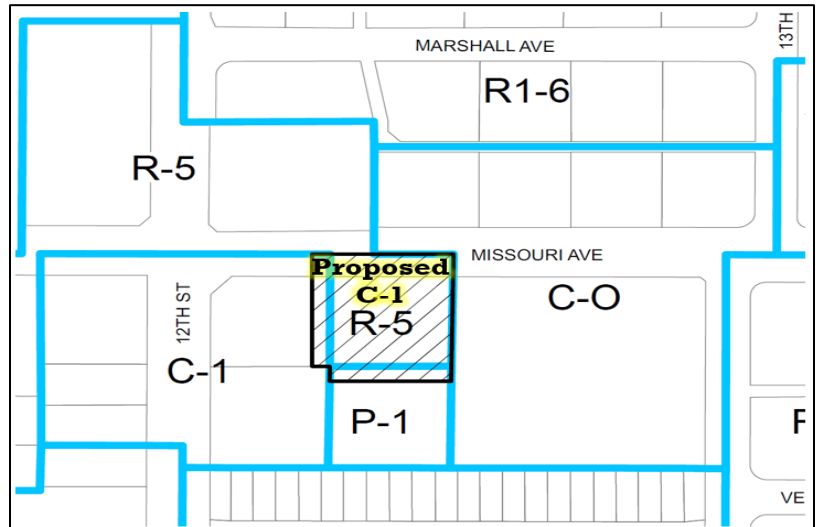

Background/Issues/Analysis

REQUEST

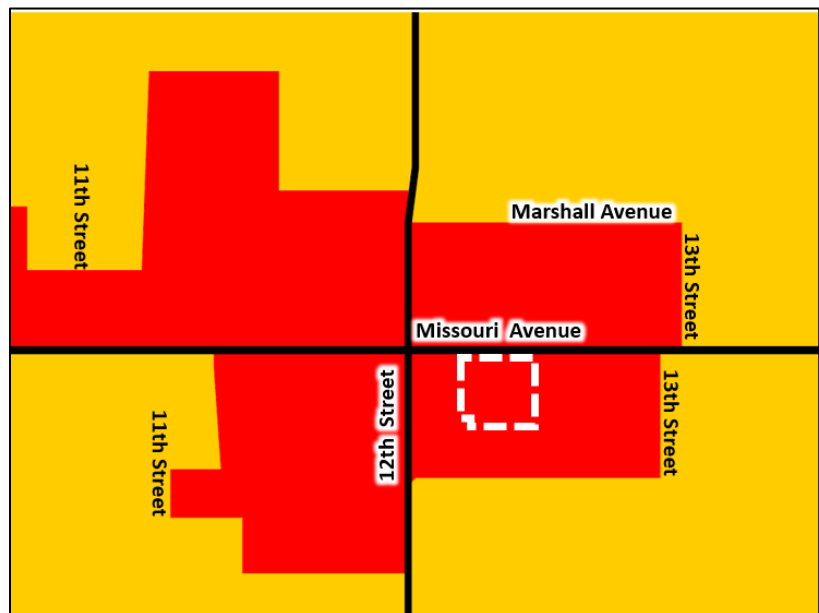
1. This request is to rezone 0.72-acres located approximately 160 feet east of the southeast corner of 12th Street and Missouri Avenue from R-5 (Multifamily Residence District), P-1 (Parking District) and C-1 (Neighborhood Retail District) to C-1 to allow commercial mixed use. The property consists of one parcel and is under the ownership of Moulin Investments, LLC.

GENERAL PLAN

2. The General Plan Land Use Map designation for the subject parcel is Commercial. The proposed rezoning is consistent with the General Plan Land Use Map designation. The surrounding General Plan Land Use Map designations are Commercial.

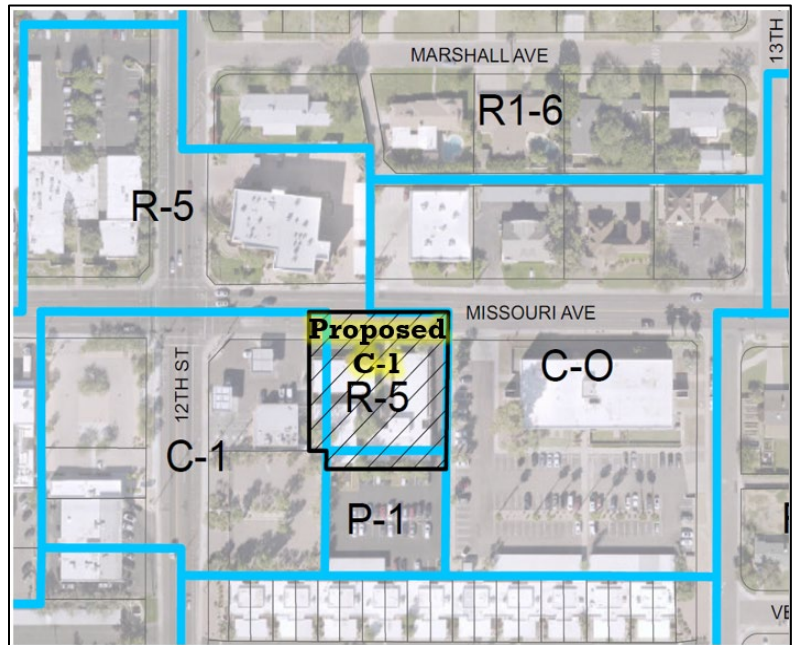
SURROUNDING LAND USE AND ZONING

3. North

To the north of the subject site, across Missouri Avenue, are two office buildings zoned R-5 (Multifamily Residence District) and C-O (Commercial Office-Restricted Commercial District).

South

Directly to the south is a surface parking lot zoned P-1 (Parking District) and beyond the parking area are townhomes zoned R-3 (Multifamily Residence District).

East

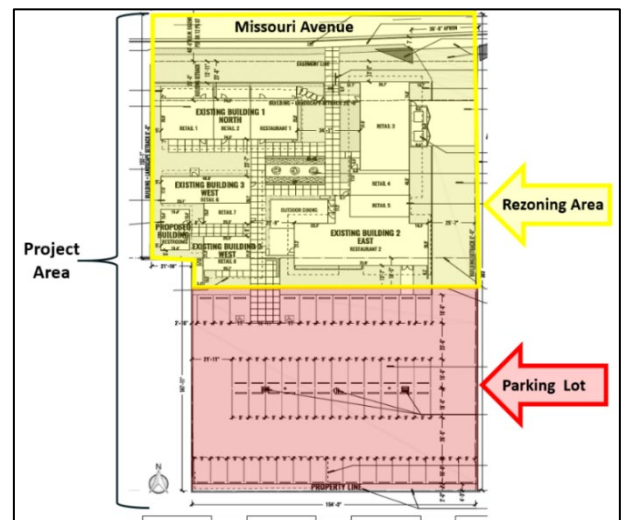
Directly to the east of the subject site is an office building zoned C-O (Commercial Office-Restricted Commercial District).

West

Directly to the west of the subject site is a gas station zoned C-1 (Neighborhood Retail).

PROPOSAL

4. The proposed development is an adaptive reuse project. The conceptual site plan includes remodel and reactivation of older office buildings with potential for mixed use commercial, including restaurants and small-scale retail spaces. The proposal also includes the addition of a building at the southwestern end of the site for potential additional restrooms. The conceptual site plan depicts a connected walkway from Missouri Avenue, through the site and to the parking lot area. Staff has requested that the pedestrian accessway be constructed of decorative material and

that the development include a minimum 1,500-square-foot active open space area to provide seating and gathering areas for patrons of the commercial development. The current development features an ornamental gate along Missouri Avenue. Staff has requested that an ornamental gate be provided as the site redevelops to provide views into the development and create a pedestrian-friendly environment. These provisions are addressed in Stipulation Nos. 1, 2 and 3.

The development area includes the rezoning site and the parking lot area to the south. The parking lot is zoned P-1, which only permits surface parking. The combination of retail and commercial uses proposed on the conceptual site plan would require that the site provide 46 parking spaces. Currently, 47 parking spaces are proposed in the P-1 area to the south to support the development.

AREA PLANS, OVERLAY DISTRICTS, AND INITIATIVES

Missouri Avenue Land Use Study

5. The Missouri Avenue Land Use Study plan was approved on January 7, 2003 and was created to provide an inventory of zoning, land uses, traffic, and findings, and recommendations for future rezoning and redevelopment proposals. The plan was developed by City of Phoenix Planning staff, nearby residents and Camelback East Village Planning Committee members. The plan identifies six elements to consider when making rezoning decisions. The proposal is supported by four of the elements which include the following: Land Use, Neighborhood, Conservation, Rehabilitation and Redevelopment, and Housing.

The Land Use Element identifies that a mixed land use pattern should be promoted to minimize travel distances. The proposal offers nearby residents with food and retail

options without long travels. The Neighborhood element identifies a policy that encourages new land uses that are supported by the General Plan and discourages non-residential uses that are not compatible in scale and character with the nearby residences. The proposal is consistent with the General Plan, compatible with the surrounding uses in terms of scale and intensity and will offer the community an amenity with retail and restaurants. Lastly, the Conservation, Rehabilitation and Redevelopment elements state that preservation, maintenance and improvement of property conditions should be encouraged when transitioning land uses. The proposal is an adaptive reuse project that will improve the site with added amenities in the Village and for nearby residents.

Tree and Shade Master Plan

6. The Tree and Shade Master Plan has a goal of treating the urban forest as infrastructure to ensure that trees are an integral part of the city's planning and development process. A vision in the master plan is to raise awareness by leading by example. To accomplish the vision and goal of the policy document, Stipulation No. 4 recommends that the developer provide a detached sidewalk along Missouri Avenue with shade trees planted near the sidewalk to create a comfortable and pedestrian friendly environment for the commercial site.

Complete Streets Guiding Principles

7. In 2014, the Phoenix City Council adopted the Complete Streets Guiding Principles. The principles are intended to promote improvements that provide an accessible, safe, connected transportation system to include all modes, such as bicycles, pedestrians, transit, and vehicles. To this end, developments should offer connected and shaded pedestrian walking paths. Staff has requested that the pedestrian pathway connect from the sidewalk, through the site and to the parking lot. This is addressed in Stipulation No. 4.

Comprehensive Bicycle Master Plan

8. The Comprehensive Bicycle Master Plan supports options for both short- and long-term bicycle parking as a means of promoting bicyclist traffic to a variety of destinations. While the conceptual site plan does not depict bicycle parking on-site, staff recommends that a minimum of 10 inverted-U bicycle parking spaces be provided and located near the entrance to each building. The bicycle racks should be an inverted-U design where both ends of the "U" are affixed to the ground and installed per the requirements of Walkable Urban Code in Chapter 13 of the Phoenix Zoning Ordinance. This provision is addressed in Stipulation No. 5.

COMMUNITY INPUT SUMMARY

9. At the time this staff report was written, staff had received numerous letters and emails of support as well as petitions of support which are attached to this staff report.

INTERDEPARTMENTAL COMMENTS

10. The Street Transportation Department has indicated that the developer shall dedicate 13 feet of right-of-way along Missouri Avenue and update all existing off-street improvements to current ADA guidelines. These are addressed in Stipulation Nos. 6 and 7.
11. The City of Phoenix Floodplain Management division of the Public Works Department has determined that this parcel is not in a Special Flood Hazard Area (SFHA), but is located in a Shaded Zone X, on panel 1745 L of the Flood Insurance Rate Maps (FIRM) dated July 4, 2017.
12. The City of Phoenix Water Services Department has noted the site has existing water and sewer mains that can potentially serve the proposed development, however there is potential need to up size existing water and sewer infrastructure mains so that any remodels or new buildings will be able to meet domestic and fire code requirements.
13. The City of Phoenix Fire Department has commented that no fire code issues are anticipated with this case and the site and/or buildings shall comply with the Phoenix Fire Code.
14. The site has not been identified as being archaeologically sensitive. However, in the event archaeological materials are encountered during construction, all ground disturbing activities must cease within 33-feet of the discovery and the City of Phoenix Archaeology Office must be notified immediately and allowed time to properly assess the materials. This is addressed in Stipulation No. 8.

OTHER

15. As part of the Reimagine Phoenix initiative, the City of Phoenix is committed to increasing the waste diversion rate to 40 percent by 2020 and to better manage its solid waste resources. Section 716 of the Phoenix Zoning Ordinances establishes standards to encourage the provision of recycling containers for multifamily, commercial and mixed-use developments meeting certain criteria. The provision of recycling was not addressed in the rezoning request.
16. Development and use of the site is subject to all applicable codes and ordinances. Zoning approval does not negate other ordinance requirements. Other formal actions such as, but not limited to, zoning adjustments and abandonments, may be required.

Findings

1. The proposal is consistent with the Commercial General Plan Land Use Map designation and the Missouri Land Use Study Area.
2. The proposal is compatible in scale and character with the surrounding land uses.

3. The proposal will adaptively reuse an existing building and will add an active shopping and dining area for nearby residents.

Stipulations

1. The development shall provide a minimum 1,500 square foot centralized open space gathering area and shall include amenities such as benches, a ramada, and water feature or other similar amenities as approved by the Planning and Development Department.
2. There shall be a pedestrian accessway connecting the sidewalk along Missouri Avenue through the site to the parking lot, consisting of decorative material such as pavers or stamped, scored or colored concrete or other similar material, as approved by the Planning and Development Department.
3. Any pedestrian gate along Missouri Avenue shall be ornamental and provide view into the development, as approved by the Planning and Development Department.
4. The sidewalk along Missouri Avenue shall be detached with a minimum 5-foot wide landscape strip located between the sidewalk and back of curb and shall include minimum 2-inch caliper shade trees planted a minimum of 20 feet on center or in equivalent groupings and adjacent to the sidewalk, as approved by the Planning and Development Department.
5. A minimum of 5 inverted-U (10 bicycle parking spaces) shall be provided within the development and placed near building entrances as required per Section 1307.H. of the Phoenix Zoning Ordinance.
6. A 13-foot right-of-way shall be dedicated for the south half of Missouri Avenue consistent with the existing right-of-way easement, as approved by the Planning and Development Department.
7. The developer shall construct all streets within and adjacent to the development with paving, curb, gutter, sidewalk, curb ramps, streetlights, median islands, landscaping and other incidentals as per plans approved by the Planning and Development Department. All improvements shall comply with all ADA accessibility standards.
8. In the event archaeological materials are encountered during construction, the developer shall immediately cease all ground-disturbing activities within a 33- foot radius of the discovery, notify the City Archaeologist, and allow time for the Archaeology Office to properly assess the materials.

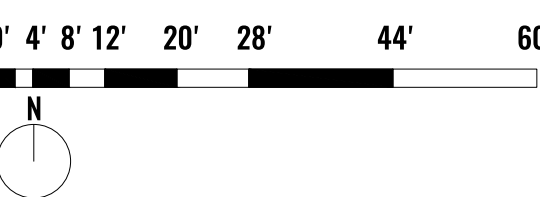
