

### **CONDITIONAL APPROVAL – ABND 250019**

At that time a new submittal will be required along with the required payment for the abandonment process. A one time, **one year** extension can be requested prior to the expiration date, with applicable extension fee due.



**SAFStor** Applicant: Request to abandon: To abandon an irregular shaped drainage easement that extends north to south on the east side of the property located at 4125 East Baseline Road. Purpose of request: The applicant states the property is currently underdeveloped but was recently approved for a special permit to allow for the development of a self-storage facility. The existing drainage easement is undersized for the proposed new development and associated improvements. Thus, a new drainage easement is proposed to service the property site.
