

City Staff Comments and Recommendations

PDD Civil Reviewer: "I recommend approval with the stipulation that Water Services Department approves as well. My concern would be the existing taps and fire hydrants existing on this water main that feed other sites. Replacing those lines may be a stipulation from the Water Department."

Street Transportation: "No comments."

Street Transportation, Lights: "Recommend approval."

Street Transportation, Utility Coordination: "The Street Transportation Department Utility Coordination has no comments."

WSD Water & Sewer Reviewer: "WSD has No stipulations for this abandonment." Water line currently within PUE is to be abandoned per CPWT 2015392.

Planning & Zoning: "No Site Planning issues; if no utility companies need this PUE then I have no issues."

Light Rail: No comments received. **Traffic Review:** "Recommend approval." **Solid Waste:** "Recommend approval."

Public Transit: "Public Transit Department does not have comment."

Southwest Gas: "After reviewing the plans for the above-referenced project, it has been determined that there are no apparent conflicts between the Southwest Gas system and your proposed abandonment of the public utility easement. Arizona Public Service: "APS has no facilities within the abandonment area in ABND200567 and has no objection to the proposed PUE abandonment."
