"I have reviewed the abandonment request at ABND 220004 APN 102-38-011L in Phoenix, {Maricopa County}, AZ. Based upon the supplied drawings/exhibits that you've submitted it has been determined that COX has no facilities within the easements and therefore we approve your request to abandon.

Please note that although Cox Communications approves this abandonment, we do so with the understanding that we will not assume any construction, relocation and/or repairs costs associated or in result of this abandonment."

### APS – James Generoso:

"APS has no objection to ABND 220004. The subject property is outside of our service territory."

### **CenturyLink – Mary Hutton:**

"Qwest Corporation d/b/a CENTURYLINK QC ("CenturyLink") has reviewed the request for the subject vacation/abandonment and has determined that it has no objections with respect to the areas proposed at this project site.

It is the intent and understanding of CenturyLink that this notice shall not reduce our rights to any other existing easement or rights we have on this site or in the area.

This vacation response is submitted WITH THE STIPULATION that if CenturyLink facilities are found within the vacated area as described, the Applicant will relocate the facilities at Applicant's expense and within quidelines set by CenturyLink and all regulating entities. All relocations will be done under the supervision of a CenturyLink Inspector."

"Salt River Project has no objection to the abandonment of the easement and right of way as shown in your application ABND220004 at 79th Ave and Encanto Boulevard."

# **Southwest Gas – Tami Garcia:**

"After reviewing the plans for the above-referenced project, it has been determined that there are no apparent conflicts between the Southwest Gas system and your proposed abandonment as shown on the application you provided. Southwest Gas would like to recommend the abandonment of the roadway easement and the Detention force main easement located at the above-referenced location."

# **Stipulations of Conditional Approval**

The request of abandonment ABND 220004 is conditionally approved and the following stipulations will need to be met:

- 1. Either a or b shall be complied with:
  - a. All utilities shall be relocated to locations approved by each affected utility company. All work is to be done by each affected utility company at no expense to the affected utility company. An appropriate performance agreement, in an approved form and cost amount, must be posted with the Planning and Development Department to guarantee the improvements.
  - b. All right-of-way shall be retained as a public utilities easement with 24-hour vehicle maintenance access.
- 2. Consideration which provides a public benefit to the City is required in accordance with City Code Art. 5, Sec. 31-64 and Ordinance G-5332. Cost for abandoned Right-of-Way adjacent to property not zoned single family residential will be \$500 OR Fair Market Value whichever is greater. Cost for property zoned single family residential is \$1.00 a square foot for the first 500 square feet, \$0.10 a square foot thereafter; OR Fair Market Value at the option of the Planning and Development Director or designee. The applicant shall submit calculation and fee to Planning and Development Department. The applicant shall request a selection of approved appraisers from the current list maintained by the Real Estate division of the Finance Department.
- 3. No right-of-way within 35 feet of the Encanto Avenue monument line may be abandoned.
- 4. The above stipulations must be completed within **two years** from the conditional approval decision dated **March 24, 2022.**
