RESOLUTION

A RESOLUTION AMENDING THE VILLAGE PLANNING HANDBOOK TO REALLOCATE THE DISTRICT APPOINTMENTS TO EACH VILLAGE TO REFLECT NEW CITY COUNCIL DISTRICT BOUNDARIES.

WHEREAS, the new City Council district boundaries are effective as of January 1, 2024; and,

WHEREAS, Village Planning Committee appointments are in proportion to the City Council District areas in the urban villages; and,

WHEREAS, the City Council now wishes to reallocate district appointments to each village to reflect the new district boundaries.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PHOENIX, as follows:

SECTION 1. The Village Planning Handbook, established with Resolution 16870 and subsequently amended, is hereby amended to revise the Village Planning Committee Appointment table as follows with deletions struck through and additions bolded/underlined:
