Item 112, Rezoning Application Z-53-22-8, is a request to rezone 288.63 acres located approximately 860 feet south of the southwest corner of 51st Avenue and Carver Road, from S-1 (Ranch or Farm Residence), S-1 (Approved C-2 PCD), S-1 (Approved R-2 PCD), S-1 (Approved R-3 PCD), S-1 (Approved R-3A PCD), S-1 (Approved R1-10 PCD), S-1 (Approved R1-18 PCD), S-1 (Approved R1-8 PCD), S-1 (Approved RH/R1-10 PCD) to PUD to single and multifamily residential, commercial uses, and some commerce park.

The applicant requested the item be continued to the May 15, 2024, City Council Formal Meeting to allow the development team to continue discussions with the community.
