

# **CONDITIONAL APPROVAL – ABND 210027**

Location:	Southwest Corner of Union Hills and 11th Avenue
<u>Applicant</u> :	Jeff A. Giles
<u>Request to abandon</u> :	The north 20 feet of the existing 33' PUE as dedicated on the final plat in Boon 335 Page 16.
<u>Purpose of request</u> :	A private accessway is proposed to be constructed within the area to be abandoned. In order to construct public water and sewer facilities within the private accessway, this portion of the existing P.U.E. is required to be abandoned.

## **Utility Provider Comments and Recommendations:**

### SRP – Sherry Wagner:

"Salt River Project has no objection to the abandonment of the 20' as shown in your application ABND210027 on the southwest corner of 11th Avenue and Union Hills Drive. This is in the Arizona Public Service serving area."

## APS – James Generoso:

"APS opposes this abandonment request and recommends denial of it. APS operates and maintains an existing overhead 69kV electric transmission line running east-west within the 33' PUE of which the applicant is seeking to abandon the northerly 20'. The proposed abandonment would leave only a 13' wide PUE which would create inadequate access and workspace for APS to maintain this electric transmission line."

## Cox Communications – Zach Lawson:

"I have reviewed the abandonment request at ABND 210027 - APN 208-03-299C in Phoenix, {Maricopa County}, AZ. Based upon the supplied drawings/exhibits that you've submitted it has been determined that COX has no facilities within the easements and therefore we approve your request to abandon.

Please note that although Cox Communications approves this abandonment, we do so with the understanding that we will not assume any construction, relocation and/or repairs costs associated or in result of this abandonment."

## Southwest Gas – Steve Salazar:

"The partial release of this Federal Patent Easement has been approved and signed by our Vice President."

#### Centurylink – Mary Hutton:

"Qwest Corporation d/b/a CenturyLink QC("CenturyLink") has reviewed the request for the subject vacation and has determined that it has no objections with respect to the areas proposed for vacation as shown and/or described on Exhibit "A", said Exhibit "A" attached hereto and incorporated by this reference.

It is the intent and understanding of CenturyLink that this Vacation shall not reduce its rights to any other existing easement or rights it has on this site or in the area.

This vacation response is submitted WITH THE STIPULATION that if CenturyLink facilities are found and/or damaged within the vacated area as described, the Applicant will bear the cost of relocation and repair of said facilities."

## **Stipulations of Conditional Approval**

The request of abandonment ABND 210027 is conditionally approved and the following stipulations will need to be met:

- All utilities shall be relocated to locations approved by each affected utility company. All work is to be done by each affected utility company at no expense to the affected utility company. An appropriate performance agreement, in an approved form and cost amount, must be posted with the Planning and Development Department to guarantee the improvements.
- 2. The abandonment must be completed within **two years** from the conditional approval decision dated **June 30, 2021.**
